The Immigration and Deportation Act, 2010 (Act No. 18 of 2010)

The Immigration and Deportation (General) (Amendment) (No. 2) Regulations, 2022

IN EXERCISE of the powers contained in section 59 of the Immigration and Deportation Act, 2010, the following Regulations are made:

1. These Regulations may be cited as the Immigration and Deportation (General) (Amendment) (No. 2) Regulations, 2022 and shall be read as one with the Immigration and Deportation (General) Regulations, 2011, in these Regulations referred to as the principal Regulations.

Title and Commencement

2. The principal Regulations are amended by the insertion of the following new regulation immediately after regulation 40.

Inserion of new regulations

41A. Regulations 17, 18, 21, 37 and 38 to relating to the visa application requirements shall not apply for citizens of countries specified in the Fifth Schedule.

Disapplication of visa application requirements

Amendment

- 3. (1) The principal Regulations are amended in regulation 52 by
 - of regulation of the figure "1" immediately after "52";
 - (b) insertion of the following new subregulation:
 - (2) Despite subregulation (1), the visa fees specified under item C of the Fifth Schedule are waived in respect of citizens of countries specified in the Fifth Schedule.
- 4. The principal Regulations are amended by the insertion of the new Schedule set out in the Appendix immediately after the Fourth Schedule.

Insertion of 5th Schedule

5. The Immigration and Deportation (General)(Amendment) Regulations, 2022 are hereby revoked.
